CONTRACT FOR ADMISSION BETWEEN BRIGHT EDUCATIONAL SERVICES & THE GUARDIAN

This Agreement made on this date between Sri/Smt

PS hereinafter refer to as the First Part.

AND

Bright Educational Services a ownership company situated at Champasari, Parvati Sadan, Prafulla Nagar, Main Road, Siliguri, W.B. 734003 represented by its owner Sri Prakash Gupta of the OTHER PART.

WHEREAS by signing the agreement both parties have agreed the following terms and condition and agreed that both shall abide by clause and the sub clauses written hereinunder :-

1. Bright Educational Services will receive all the Fee/Amount directly in its name
2. Guardian will deposit all other amount directly to University / College administration of in the name of the University / College.
3. If after accepting the service charge / registration fees, Bright Educational Services fails to admit the student in the institution as was agreed upon Bright Educational Services will return 75% of the money to the student within 60 days from the date of last discussion.

8. That this agreement will cease to exist the day admission has been done.
9. This agreement shall be construed in accordance with the laws in force in India. If any controversy or dispute should arise between the parties in performance, interpretation or application of the agreement involving any matter or any term or condition herein contained shall be referred to the arbitration of a sole Arbitrator under the provision of the Indian Arbitration and Conciliation Act. 1996 to be appointed by the Bright Educational Services and the parties have agreed that the sole Arbitrator shall have summary power and may interim order /s and Award/s and non speaking order /s whether interim/ or final. The Award and /or order / made by him shall be final and the parties agreed to follow the same without objection.
10. Any such Arbitration shall be :-
 - i. If Student Proceeded in English and place of arbitration shall be in Siliguri and
 - ii. Concluded within 3 (three) month of the appointment arbitrator
 - iii. Any arbitral judgment made in accordance with the provision shall be conclusive and binding on the parties and that none of the parties shall be entitled to commence or maintained any action in a court of law. in relation to the dispute except for the enforcement of and arbitral award granted pursuant to this clause 26 or to the extent permitted under law.
